1. INVOCATION

Mayor Pro Tem Kevin Mosher gave the invocation.

2. OPEN THE MEETING/PUBLIC HEARING AND ANNOUNCE THAT A SUPER QUORUM IS PRESENT

3. Hearing #1 Discuss the Proposed City Property Tax Rate of \$.546422 per \$100 In Value for 2021-22

Mayor Olson asked if anyone had questions on the tax rate and waited several Minutes to see if anyone else showed up to the Public Hearing. No one had any questions regarding the Proposed City Property Tax Rate.

8. DISCUSSION: Consider & Act on Ordinance 091421 Adopting the Annual Budget for 2021-22.

Mayor Pro Tem Mosher made the motion on adopting the Annual Budget for For 2021-22. Councilman Clements seconded the motion. The motion passed 5-0.

9. ACTION/DISCUSSION: Consider and Act on a Resolution 091421 of the City

Council of the City of Caddo Mills, Texas approving a negotiated settlement between Atmos Cities Steering Committee ("ACSC") and Atmos Energy Corp., Mid-Tex Division Regarding the Company's 2021 Rate Review Mechanism Filing; declaring existing Rates to be unreasonable; adopting tariffs that reflect rate adjustments consistent with the negotiated settlement; finding the rates to be set by the attached settlement tariffs to be just and reasonable and in the Public interest approving an attached exhibit establishing a Benchmark for Pensions and retiree medical benefits; Approving an attached exhibit regarding Amortization for

regulatory liability; requiring the company to reimburse ACSC's reasonable ratemaking expenses; determining that this resolution was solution was passed in accordance with the requirements of the Texas open meetings act; adopting a savings clause; declaring an effective date; and requiring delivery of this resolution to the company and the ACSC's legal counsel.

Mrs. Dattomo spoke on the RRM, stated it was slightly different this year due to Railroad commission. RRM is set for the company to recover the rates for the Infrastructure updates that has been put in place. Dattomo stated that the increase is around 70 cents. Last years was around 55 cents. Mayor Pro Tem Mosher made the motion on approving a negotiated settlement between Atmos Cities Steering Committee ("ACSC") and Atmos Energy Corp., Mid-Tex Division Regarding the Company's 2021 Rate Review Mechanism Filing. Councilman Verity seconded the motion. The motion passed 5-0.

10. ACTION/DISCUSSION: Consider and Act on resolution 091421-1 with TxDot for a temporary Street closure of State Right-of-Way. The City is requesting closure of Main Street and HWY 66, and closure of Main Street and Gilmer Street (in front of the fire station.)

The purpose of the closure is for Fall stroll on October 30th, 2021.

City Manager McMahan stated the Chamber of Commerce sponsored the Fall Stroll last year. He said for safety reasons we need to close the streets like we do for Fox Fest. He said we have to go through TxDot for the street closures. Mayor Pro Tem Mosher motion to approve for the agreement for the street close for the Fall Stroll. Councilman Clements seconded the motion. The motion passed 5-0.

11. ACTION/DISCUSSION: Consider and Act on resolution 091421-2 adopting
The 2021 Hunt County Hazard Mitigation Action
Plan.

Mayor Pro Tem Mosher made the motion on adopting resolution 091421-2. Councilman Davies seconded the motion. The motion passed 5-0.
