1. INVOCATION

2. OPEN THE MEETING AND ANNOUNCE THAT A SUPER QUORUM IS PRESENT

a. PUBLIC HEARING: Hold a public hearing to change the zoning classification fromSF-2 TO C1- Light Commercial on property identified by Hunt CAD as Property ID: 53671, S4360 ORIG TOWN OF CADDO MILLS BLK B LOT 3A ACRES .396located at 2508 First Street Caddo Mills, Texas 75135

Mayor Pro Tem Olson, advised that the engineer has done the estimates on the In ground storage tanks. Olson advised that they are working on the agreement with the school to share the costs for the 300k gallon storage tanks. Councilman Richardson stated that he was at the school board meeting and the agreement will basically be same as it is now. Councilman Richardson made the motion to approve the agreement as is; and subject to any changes agreed to by the City Manager and be presented to the Council next meeting. Councilman Bentley seconded the motion. The motion passed 4-0.

12. ACTION/DISCUSSION: Consider and Act on Resolution 020921-2 requesting Financial assistance from the Texas Department of Transportation for Airport improvements.

Mayor Pro Tem Olson advised that the City has been working on a grant for the Airport for over three years. Mayor Pro Tem Olson stated that the City has been Approved for the grant for the airport improvements. Councilman Bentley made The motion on Resolution 020921-2 requesting Financial assistance from the Texas Department of Transportation for Airport improvements. Councilman Clements seconded the motion. The motion passed 4-0.
